Anyone who has driven past the Uralla Visitor Information Centre would have noticed the construction barriers now in place as work progresses on the VIC improvement project. This project has been made possible by significant grant funding provided by the NSW State Drought Stimulus Government's Package and the Australian Federal **Government's Drought Communities** Extension Programme. Over the next few months internal and external renovations will be completed along with landscaping works and the installation of a pergola.

Councillor workshops and briefings now open to the public

In a move to increase transparency and effective communication with the community, Council has opened councillor workshops and briefings to the public, with the exception of agenda items of a confidential nature as set out under Section 10A of the NSW Local Government Act 1993. The decision to open workshops to the public reflects Council's strategy to provide open, accountable and transparent decision making for the Uralla Shire community.

Agenda items to be considered at councillor workshops or briefings will be published by way of public notice three business days prior to the workshops. Agenda items to be heard in closed briefings will still be listed on the agenda, with the reason for closing the item. Councillor workshops and briefings are conducted by the General Manager to provide information to councillors and to assist Council's effective and strategic decision making at formal meetings of Council. Councillor workshops are an informal gathering of Council, meaning that the formal requirements of Council's Code of Meeting Practice do not apply and workshops are not recorded or webcast.

Construction commences on the Bundarra Sewerage Scheme

Construction has now commenced on the Bundarra Sewerage Scheme. Council is pleased with the rapid commencement of construction on the project and we are working with Ledonne Constructions so that the works go as smoothly, safely, and as quickly as possible. Assuming no unforseen delays, Council anticipates the scheme will be commissioned by late 2021.

Funding has been provided by the NSW Government through its Restart and Safe and Secure Water Program to enable the \$8.81 million project to go ahead. Council was awarded grant funding of \$3.675 million towards the project from the Restart NSW Water Security for Regions Program, this has now been increased to \$6.354 million from the Safe and Secure Water Program. Council will fund the \$1.97 million balance from Council reserves and annual sewerage charges.

The Bundarra Sewerage Scheme project is a key component of Council's commitment to provide efficient and environmentally-sound sewerage services in Bundarra. The project will provide reticulated

sewerage infrastructure and services to approximately 165-171 properties within the Bundarra area.

The project consists of the construction of a low pressure sewer reticulation network within the township, a sewage pumping station and rising main to deliver Bundarra's wastewater to the treatment plant, and a sewage treatment plant including ponds, storage lagoons and an irrigation system for the treated effluent. There should be no discharge of wastewater from the site.

Council is committed to the successful delivery of the project, which will provide numerous public health, economic, and environmental benefits to the Bundarra community and across the region.

Council's То increase transparency and accountability, Councillors will now table a statement of all claims made under the Councillor Expenses and Facilities Policy at each Ordinary meeting as part of their monthly delegate report.

Councillor expenditure is public and tabling the information at Council meetings will make it more accessible by the public. Further, Council's intention is that the decision will bolster confidence community in the amounts councillors are reimbursed for undertaking their official duties.

The key objectives set out in Council's Councillor Expenses and Facilities Policy state that councillor expenses and facilities are acceptable to and meet the expectations of the local community, and that Councillors are not financially disadvantaged in undertaking their civic duties. By increasing awareness of the policy, Council encourages all residents to run for public office in the upcoming Local Government elections, including those who may not reside in the Uralla township and would need to travel to Council meetings or other official functions.
