#### MIHI CREEK BRIDGE REPLACEMENT PROJECT COMPLETED

Uralla Shire Council has completed the \$520,000 upgrade of the Mihi Creek Bridge, with the new two-lane bridge officially opened by Member for Northern Tablelands Adam Marshall and Deputy Mayor Isabel Strutt on 9 May.

Cr Strutt said the Mihi Creek Bridge Replacement Project, which was jointly-funded by Council and the NSW Government through its Fixing Country Roads Program, will deliver transport efficiencies to the local livestock and forestry industries through reduced travel time and improved accessibility.

"Council is delighted to have finalised the Mihi Creek Bridge Replacement Project, which has enabled the replacement of the old

single lane timber deck with a two-lane concrete deck, comprising pre-cast concrete panels designed to higher load standards," Cr Strutt said.

"Council's staff and the local contractors who were engaged to assist in delivering this project have done an outstanding job, and I am pleased that the project has been completed within the allocated budget and set timeframe," she said.

#### PLEASE REFRAIN FROM SMOKING IN PLAYGROUNDS AND AT SPORTING GROUNDS

Council has received complaints regarding smoking at or in the vicinity of children's playground areas. Not only does this practice provide for a harmful environment for children and other people, it is against the law.

#### Smoke-free areas

Smoking is banned in all enclosed public areas and certain outdoor public areas, under the NSW *Smoke-free Environment Act 2000* and the *Smoke-free Environment Regulation 2016*. These bans are intended to protect people from harmful second-hand tobacco smoke. There is no safe level of exposure to second-hand smoke. #### Outdoor public areas

Some of the places where smoking is banned:

- Within 10 metres of children's play equipment in outdoor public places.
- Public swimming pools.
- Spectator areas at sports grounds or other recreational areas used for organised sporting events.
- Within 4 metres of a pedestrian access point to a public building.
   Why are the laws in place?

These smoking bans in outdoor public areas have been made because:

- They are often visited by children and families and they can be crowded.
- They allow limited opportunity for people to avoid second-hand smoke.
- This approach will achieve an important reduction in many people's exposure to second-hand smoke.
- This approach will create a more supportive environment for those who have quit smoking.

#### **Enforcement of smoking bans**

NSW Health inspectors can issue cautions or **on the spot fines of \$300** to people who break the smoking bans.

#### **ZNET URALLA NEWS**

#### How is Uralla Shire tracking towards 100% renewable?

Our Shire is now generating 18% of our predicted electricity usage from solar PV. This is a great achievement with over two thirds being achieved since we got our Z-NET Blueprint in 2015. At this rate we will reach 100% renewable electricity by 2030 just by people power!

All the work is done by our businesses and homes to reduce the actual amount of power they use, by updating thermal building fabric, LED light bulbs, efficient appliances etc, and purchasing Greenpower are also making a contribution.

Achieving sustainable wood use for heating is the next big step as burning wood is nearly half our energy use. With our new project Elephant in the Woodlands, Z-NET Uralla will be working with the community to help reach this goal.

#### TIPS FOR MINIMISING WOOD SMOKE POLLUTION

During the New England winter months, many people in Uralla Shire rely on wood to heat their homes. It is estimated that wood heaters in the Uralla township heat around 70% of the dwellings.

With wood heating comes the generation of smoke. Wood smoke provides for harmful pollution which affects lung health in the same way tobacco smoking causes respiratory disease.

Burning wood efficiently is the key to minimising smoke generation while heating your home. By taking a few simple steps you will assist in minimising smoke generation. This can be done by:

- Only burning dry, seasoned wood.
- Storing wood in dry places on a solid platform such as concrete.
- Burning wood at hot temperatures to limit fine particle pollution.
- Making sure vents are open to draw in air and increase combustion temperature.
- Avoiding slow combustion of wood over night.
- Maintaining a clean chimney and well sealed fire in closed wood heaters and wood stoves.



### **GOVERNMENT MOBILE SERVICE**

Australian Government Mobile Service Centres travel to rural and regional communities to provide community members with information and access to government services. They provide personalised face-to-face servicing to those who may not have easy access to a Department of Human Services office. Staff from the Department of Human Services travel with the Mobile Service Centres and can help the community with Centrelink, Medicare, Child Support & Australian Hearing payments and services.

The van will be in **Uralla** on 19 June from 9am to 4pm in the VIC Carpark and **Bundarra** on 22 June 2018 from 9am to 3pm.
