Mayor's Message

t's been great to get back into the swing of things with Council and Committee meetings this month after our brief January recess. We reviewed two important reports at our Budget Review and Finance Committee on the water and sewer service review and the Horizontal Service Review priority actions. The latter review identified a number of items to investigate which may offer cost savings in the forthcoming budget.

Council reviewed a number of reports at the February Ordinary meeting, including changes to the Code of Meeting Practice, the status of the Integrated Water Cycle Management Strategy and Water and Sewer Asset Management Plans, and a series of matters raised by your elected Council. Anyone interested in the details can read the full business paper and Council's formal resolutions contained in the meeting minutes on the Council website. We also encourage you to contact any one of your local Councillors to discuss issues with, or to send any queries to Council directly.

The free business disaster readiness online training webinars funded by the NSW Government's Bushfire Community Resilience and Economic Recovery Fund – Phase 1 will take place this month. Any businesses who may not have been able to attend can watch the training at a later date as the sessions will be recorded and available on the Council website. The training utilises tools from Resilience NSW's Get Ready Business framework, which is a fantastic tool for businesses to prepare for any kind of disruption. The first review of the Uralla Shire Local Strategic Planning Statement (LSPS) is currently underway with the document on public exhibition and open for feedback. The LSPS is a key document used to guide local strategic land use planning in Uralla Shire having regard to economic, social and environmental matters. It will help Council with the planning priorities for the area, the actions required to achieve those priorities and the basis upon which to monitor progress. As this planning relates to the next 20 years, it's important we hear from the community about what Council should do to address our shared land use goals and priorities. The LSPS will be on public exhibition to 19 April 2021.

We received a positive response to the Listening Posts held in Uralla and Bundarra, and planning is underway for Council to extend the trial to Invergowrie, Kingstown and Kentucky. Feedback from these listening posts will be considered by Council in the future development of strategic documents and Council's annual Operational Plan, and will assist Council's decision making.

Council Listening Posts

Council held a successful first run of Listening Posts in the first week of February, during which members of the community were invited to stop and have a chat with councillors and senior staff, to give Council feedback on any topic and to assist Council with its future planning and decision making.

More than 100 people contributed over the course of three days, by telling their stories and identifying important community issues. Councillors and senior staff asked community members to describe what they valued most about the Uralla Shire and opportunities for improvement over the next 10 years.

Common themes raised by the community included the value of the Uralla Shire community and the friendliness of its people, as well as the importance of maintaining the historical and small town charm of the area. Ideas for the future included infrastructure upgrades, economic development, improved accessibility, and renewables.

Given the early success, planning is underway for Council to extend the Listening Posts to Invergowrie, Kingstown and Kentucky. Dates will be publicised on Council's website and facebook page.

Draft Policy on Public Exhibition: Code of Meeting Practice 2021

At its Ordinary Meeting held 23 February 2021, Council resolved to place the Draft Code of Meeting Practice 2021 on public exhibition for a period of 28 days.

The draft policy has been amended as follows:

- To remove reference to Pre-meeting briefing sessions;
- That minutes include the names of Councillors voting for and against each motion;
- That members of the public can register to speak on any topic at a Council meeting;
- Reasons for refusing an application to speak or present material at a public forum in a Council meeting must be in writing and provided as soon as practicable;
- That speakers who engage in inappropriate conduct can be refused by the Council further applications to speak at a public forum; and
- That the Council and committee meeting webcasts will be retained on the Council website for 12 months.

The Draft Code of Meeting Practice can be viewed on Council's website or on request at Council's Administration Offices, 32 Salisbury Street.

Construction Underway at the Bundarra Sewerage Treatment Plant

The initial stages of the Bundarra Sewerage Scheme are underway with Ledonne Constructions working at the site of the Bundarra Sewerage Treatment Plant (STP) just off Mount Drummond Road, Bundarra. The dry weather has enabled construction of the two initial oxidation ponds. This is primarily a bulk excavation activity with earthmoving equipment.



The next stages of the project will be to construct the pumping station on the corner of Bombelli and Oliver Street, with the rising main progressively installed along Barraba Road to the STP. Bundarra residents will have observed the heavy duty sewer rising main pipe pallets placed in the road reserve in readiness for installation from the village to the STP.

Following the construction of the rising main to the STP, the installation of mains through the village and over the bridge will be undertaken, and then the varied domestic connections within the private properties.

The Bundarra Sewerage Scheme is jointly funded by the NSW State Government's Safe and Secure Water Program and Uralla Shire Council. Assuming no unforseen delays, Council anticipates the scheme will be commissioned by late 2021.

The Uralla Shire LSPS is under its first review and Council is seeking feedback and input from the community.

The LSPS sets a 20-year vision for land use, describes the unique characteristics which contribute to the local identity and shared community values, and is an important guide for future growth and change in the Uralla Shire. The LSPS will be used by Council and other stakeholders to inform policy development, infrastructure planning, and community service delivery.
