Applications can be downloaded on the Council website or collected from the Visitor Information Centre. The closing date is 15 November 2022.

While it has been a wet spring and there's more rain on the forecast, it's important to be ready now for the summer bushfire period. The Bush Fire Danger Period (BFDP) for the New England region commenced 1 September. During the BFDP, landowners and land

#### Residents reminded to clear the way for meter readers

Water meter reading is conducted in November and May each year in Bundarra and Uralla, with water bills due to be sent out at the end of the reading month.

Council relies on accurate and timely water meter readings to make sure you are billed correctly. You can help by allowing clear access to your water meter so meter readers can record your water use and repair or replace your water meter when required.

Council staff may not be able to read your meter if it is behind a locked gate or if it is unsafe to enter the property.

Other hazards that may prevent meter readers accessing the meter include:

- the presence of a dog
- it is buried in concrete or dirt
- it is surrounded by overgrown grass, garden or vegetation.

Please ensure there is at least one (1) metre clearance either side of your water meter and two (2) metres above it for Council staff to safely access your meter. If Council cannot safely gain access to your water meter to obtain a reading, we may have to estimate your usage.

An estimate is based on the property's previous usage pattern.

When an actual meter read can be taken following one or more estimates, the account will be adjusted so that customers are invoiced according to actual water used to date.

# Asset Management Plans on Public Exhibition

At the September Ordinary Meeting, Council reviewed the draft Asset Management Plans for its Buildings, Stormwater Drainage, and Open Spaces and Recreational Facilities assets and decided to place the documents on public exhibition to invite feedback from the community and assist Council's further development of the draft plans.

Copies of the documents are on the Council website or can be viewed upon request at the Council Customer Service Centre. Asset Management Plans are an essential strategic document of Council to help plan for sustainable maintenance of assets on behalf of the community.

# Weeds: A Threat to Native Biodiversity

Under the NSW Biosecurity Act 2015, biosecurity is everyone's responsibility. Biosecurity protects our economy, environment and community from pests, diseases, weeds and contaminants. The legislation requires landholders to control biosecurity risks on their property such as vertebrate pest animals (such as rabbits, foxes, pigs, wild dogs and cats), insects, pests and weeds.

Weeds pose a major biosecurity risk, being a threat and a barrier to the recovery of native biodiversity. Owners and occupiers of rural and urban land are reminded that it is everyone's General Biosecurity Duty to control weeds on their land.

Weed control on public land is an important function of Council to support our native plant species growing in public parks, Crown reserves and roadsides. Control of weeds on public land includes mechanical removal and herbicide application. When herbicides are used, the public will be notified.



New England Weeds Authority (NEWA) provides a service for Uralla Shire Council to manage the following noxious weeds:

- Chilean Needle Grass
- Serrated Tussock
- Privet
- St Johns Wort
- Paterson's Curse
- African Lovegrass
- Blackberry

The community is encouraged to report any of the above noxious weed species growing on the roadsides, parks and other Councilmanaged lands.

# Single Use Plastic Ban From 1 November

From 1 November, phase 2 of the NSW Government's ban on single use plastic ban will come into effect. These single use plastic items will be banned:

- Plastic straws and stirrers
- Cutlery, plates, and bowls
- Cotton buds
- Expanded polystyrene food ware and cups
- Rinse-off personal care products which contain microbeads

Single use plastic items and packaging make up over 60% of all litter in NSW.

The NSW Government's ban on single use plastic will prevent almost 2.7 billion items of plastic litter entering the NSW environment over the next 20 years.

# Catch up on your Council Meetings

At the September Ordinary Meeting, Council resolved to:

- Write to the Premier and Leader of the Opposition in an ongoing effort to overturn the advice on the management of RFS assets.
- Publish all future tender documents on Council's website and give notice on social media and in local print media.
- Refund the Rotary Club charges made to parking the MHERV clinic in Uralla, and that registered motor vehicles not selling any article in a public place and that are legally parked on Council roads do not require approval under s68 of the Act.
- Seek advice for developing a set of criteria for a Heritage Advisor and report back to Council.
- Endorse an application for grant funding under the NSW Government's Regional Housing Strategic Planning Fund.
- Reallocate funding from the Block Grant Rehabilitation Program to allow the completion of Tolleys Gully Bridge project if funding is not secured from the NSW State Government.
- Apply for funding under the Environmental Restoration and Rehabilitation Program for ecological restoration activities at Racecourse Lagoon.
- Adopt the amended Code of Meeting Practice.
- Appoint delegates to Council committees and steering groups.
- Submit an application for Supporting Medication Management in Residential Aged Care Initiative Electronic National Residential Medication Chart Adoption Grant.
- Award the tender for the refurbishment of Pioneer Park to Wallace Constructions.
