February 2010 Council Resolutions

Highlights of Council's Ordinary meeting of 22 February 2010 include the following resolutions:

- That Council comply with the request from the Deputy Director General (Local Government) requesting to refrain from committing itself to any major policy change or decisions which may have a significant financial impact for the organisation during the period of the Review of Local Government Service Delivery in the New England Area.
- That Council note the continued squeezing of the finances of local authorities in New South Wales by the announcement of the Minister for Local Government, Hon B Perry, of the pegging of the increase allowed for rate increases for the year 2010/2011 to 2.6%, being much less that anticipated cost increases especially State Government and State Instrumentality Charges and write to the Local Government and Shires Association (LGSA), noting the 2.6% increase in the rate pegging percentage, requesting that the Association once again take up the matter of the decrease in the percentage increase with the Government.
- That Council note the commencement of the NSW Electronic Housing Code Pilot Project by the Department of Planning and the Local Government and Shires Association.
- That Council not approve Development Application 452/2010 for subdivision by way of objection under State Environmental Planning Policy 1 for the land known as Lot 201 DP 1074880 as the proponent has not demonstrated special circumstances of a compelling kind to justify the exercise of discretion.
- That Council subsidise an administration charge of \$1,800 for the Bundarra Neighbourhood Aid Service for the 2009/2010 financial year.
- That Council utilise the services of Local Government Procurement wherever appropriate.

Resolutions cont:

- That Council provide financial assistance of \$1,500 to the Uralla Super Stakes Cutting Horse Event to be held in Kentucky from 16 to 18 April 2010 to assist with advertising costs.
- •That Council endorse the affixing of the Uralla Shire Council seal by the Mayor and General Manager to the Deed of Variation accepting one-off grant funding for Kamilaroi Ageing and Disability Service under the National Respite for Carers Program and the Lease Agreement with the Country Women's Association of New South Wales to rent premises in Rivers Street Inverell which is used by the Kamilaroi Ageing and Disability Service.
- That Council approve the construction of a cul de sac towards the northern end of Fitzroy Street North with a one way entry from Thunderbolts Way to the cul de sac.

URALLA SUBCATCHMENT MANAGEMENT PROJECT Creekworks – Uralla Creek

Soil Conservation Service operators, a professional tree control operator and Council Staff have been working on stabilisation and erosion control projects along Uralla Creek, above and below the highway bridge. Stream bank corners have been stabilised and strengthened using rock structures, in-stream erosion is to be curtailed with rock groynes in various localities and two rock drains have been built at Duke Street and Park Street stormwater outlets. Particular attention has been paid to the works in Porter Park. Council has provided granite rock to improve the visual amenity in the Park. This work forms part of the Uralla Subcatchment Management Plan and is a result of three years of planning by Council and partner organisations, with funding from Border Rivers Gwydir CMA and NSW Environmental Trust, delivered through the Landcare network. Council would like to thank the residents for their patience during these works in the town area. More work is being scheduled for later in the year, including attractive rock works on Rocky Creek through Alma Park.

REVIEW OF LOCAL GOVERNMENT SERVICE DELIVERY

BACKGROUND

The Uralla Shire Council was in an Alliance with the Armidale Dumaresq, Guyra Shire, Walcha and Weeds County Councils until 30 September 2009. The Department of Local Government carried out a Better Practice Review of the Alliance in February 2009. This Better Practice Review was updated following the collapse of the Alliance and issued in December 2009.

One of the recommendations within the Better Practice Review (December 2009) was that "The Minister should appoint an independent person to facilitate a review of the arrangements for delivery of local government services in the areas served by the Councils".

On Thursday, 21 January 2010, the Minister, Hon Barbara Perry, announced that she had appointed Mrs Gabrielle Kibble AO to carry out the Review. Details of the Terms of Reference can be downloaded from www.dlg.nsw.gov.au/NESACReview or information packages are available from the Council Office or any Uralla Councillor.

The Uralla Shire Council welcomes the Review and will be making a detailed submission after consultation with the Community on the service delivery currently provided and the options for the provision of these and other services into the future.

Council held a consultation meeting with the residents of Bundarra on Thursday, 11 March 2010 and will be holding a similar meeting with Uralla and surrounding areas next Thursday, 18 March 2010, at the Uralla Central School Auditorium commencing at 7.00pm.

Mrs Kibble will be attending a public consultation meeting on Tuesday, 20 April 2010, commencing at 7.00pm at the Uralla Bowling Club. As this is the only public consultation meeting to be held in Uralla, Council will be arranging for transport from Bundarra and Kingstown. Speakers at the public consultation meeting will be limited, so if you wish to speak, please ring the General Manager on 6778 6302 or email toconnor@uralla.nsw.gov.au for a place.

THE COUNCIL'S POSITION

The Uralla Shire Councillors, in a workshop prior to the February Council meeting, considered a number of opportunities (or options) to better serve the communities of New England. At the Council meeting, Council resolved broadly to remain an autonomous rural council and take every opportunity for alliances and cooperation with any other council in the region.

FACT / FICTION

During times of intense public interest and debate, information is discussed that is either fact, based on fact or fiction. Some of the following are currently doing the rounds:

· Council is broke - "Fiction"

Council is a \$16 million per annum business and on 9 March 2010 it had \$1,521,145.06 in the bank or on call, \$4,568,622.79 on one month to four month maturing term deposits or in other words \$6,089,767.85 readily available (9 March last year this was \$5,282,698.10). Council also has \$327,500 tied up in CDOs and \$500,000 in FRNs.

- Council expends 166% of its rates on employee costs ."True but Irrelevant" Council paid \$6,219,000 in employee costs while raising \$3,743,000 in rates and annual charges for 2008/2009. This is irrelevant because Council received \$3,956,000 in contracted grants for Community Services that are provided not only to Uralla residents but also New England / North West. The Community Services employee costs was \$2,298,000 in 2008/2009.
- Uralla Shire Council is heavily dependant upon Grants "Half Truth" Council received \$9,486,000 or 59% of its income in grants in 2008/2009, which included Community Grants \$3,956,000, Regional Road Grants \$1,083,000, Maitland Point Bridge Replacement \$703,000, Roads to Recovery \$422,000 and Financial Assistance Grants \$2,396,000.

Regional Roads and Maitland Point had to be matched with Council's own funds. Council has been very successful in obtaining grants and contributions and will continue this effort, particularly in the emerging environmental grants area.

AUTONMOUS / STAND ALONE

There is a subtle difference between being 'autonomous' and in 'standing alone'. Standing alone suggests isolation, which infers you build a fence around the Shire and do everything ourselves.

Autonomy means that Council would remain a separate organisation and outsource those services that are more effectively done by others and providing services to others that we can more effectively do for them. The end result is maintained local responsiveness with more efficient and effective delivery of services not only to Uralla but also to other areas of New England / North West.
