# Access to Water Meters

Residents are reminded that access to water meters is required not only to read them but also to be able to turn the water off to undertake internal repairs on taps and fittings. During the last meter reading a number of meters were difficult to access or read due to overgrown vegetation. Council requests that residents clear any vegetation or landscaping that may hamper access to the water meter.

## Uralla & District Liquor Accord

Uralla Liquor Licensees have established a local Liquor Accord. Previously liquor licensees were members of the Armidale Liquor Accord, however it was felt that the directions of that accord were not relevant to the licensed venues in and surrounding Uralla. As such, and with the approval of the Armidale Local Area Police and the Office of Liquor Gaming and Racing, Uralla & District Liquor Accord Inc has been established.

A liquor accord is simply an agreement by licensees and other stakeholders to take certain actions in local communities which aim to improve safety in entertainment areas and reduce alcohol-related anti-social behaviour, offences and violence.

Alcohol-related problems frequently result from the ways in which liquor is served and promoted. Liquor laws provide some powerful enforcement tools to address such problems, including closures of premises and a range of legal action.

Local liquor accords aim to stop problems from occurring in the first place. They have the advantage of enjoying the support and cooperation of licensees and take account of specific issues in an area.

All venues involved in the service of liquor whether it be a hotel, club, bottle shop, restaurant or winery are members of the liquor accord.

## Trial Meeting Times

One of the requests expressed in the Community Strategic Plan 2011 to 2021 was for Council to examine the proposal to commence its meeting in mid afternoon to suit residents.

The Council meeting currently commences at 12.00noon and is usually completed by 5.00pm. This was seen to exclude residents who may wish to attend a Council meeting but have work commitments.

In order to guage Community and Councillor acceptance of this proposal, Council determined to have a three month trial period from the October 2011 Council meeting.

Therefore the Council meetings of 24 October, 28 November and 19 December 2011 will commence at 4.00pm. The first section of the meeting will consist of housekeeping issues with the "Have Your Say" session commencing at 6.30pm followed by matters requiring discussion which could be of interest to residents.

The trial will give residents the opportunity to come along to the evening section of a Council meeting to learn how Council operates and comes to decisions that affect residents.

#### Proposal for

"Uralla Community Associations Incorporated"

For some time, a number of people have been discussing the idea of forming an umbrella group to involve many of the *not-for- profit groups* which operate in our shire. There are a few reasons for this:

- It is envisaged that this umbrella association would provide a better means of communication between the community groups and the Uralla Shire Council;
- It would also allow better communications *between* the groups to allow sharing of resources, linking activities for maximum impact and at the same time avoiding counter-productive clashes.
- The umbrella association, which would be incorporated, could also provide low cost access to public liability insurance for those smaller groups who do not have access to insurance through a larger "parent" body. So if your group is paying insurance and feel you are battling up hill to pay it, this may be an avenue that can help you minimize your fees.
- Once incorporated, there would only need to be one formal meeting a year the AGM to keep this association legal. That meeting would last less than 30 minutes!

A small working group has prepared a statement of objectives and a draft constitution for the proposed "Uralla Community Associations Incorporated". The next step has to be to convene a meeting of **representatives** of the *not-for-profit groups* in our shire, who may wish to participate, to discuss these documents. Remember, attending the meeting is in no way committing your group to be involved in the umbrella organisation. It is expected the representatives who attend this meeting will take away the details of discussions to share with their group, at which time decisions about further involvement could be made.

The meeting to consider these documents and the further development of the proposed "Uralla Community Associations Incorporated" will be at *5 PM, on Tuesday 16 August in the Uralla Shire Council Chambers.*
