#### **Planning Proposal Exhibition**

Council is exhibiting a planning proposal under the provisions of Section 57 of the *Environmental Planning and Assessment Act 1979*. The objective of the planning proposal is to amend the Uralla Local Environmental Plan 2012 to reclassify land from 'community' to 'operational'. The land is identified as being:

Gravel Pit - Bingara Rd Bundarra - Lot 1 DP 1062924

Bundarra West Reservoir - Muirhead St Bundarra - Lot 1 DP 1165352

Caravan Park - Queen St Uralla - Lot 30 DP 793510

Water Race - Kliendienst Rd Uralla - Lot 613 DP 755846

Uralla Shire Council is authorised to exercise the functions of the Minister for Planning & Infrastructure under section 59 of the *Environmental Planning & Assessment Act 1979* for this matter.

The planning proposal and supporting documentation are on public exhibition during business hours at the Council Offices at 32 Salisbury Street, Uralla, the Uralla Public Library, 106 Bridge Street Uralla, General Stores at Bundarra, Invergowrie, Kentucky and Kingstown or via the Council Website (www.council.uralla.nsw.gov.au) for the period Wednesday 31 July 2013 to Wednesday 28 August 2013.

Interested persons are invited to inspect the planning proposal and supporting documentation. Written submissions concerning the provisions of the planning proposal may be made to Council throughout the above mentioned exhibition period. Submissions should be in writing and can be posted to, or faxed to (02) 6778 6349, or emailed to council@uralla.nsw.gov.au. The last day for the receipt of submissions is Wednesday, 28 August 2013.

Please note confidentiality is not available to respondents. The details of any submissions may be included in a Council report or forwarded to the proponent where it may help to resolve issues raised in the submission. Information (including copies of submissions) may also be released. Submissions are balanced with Council's statutory obligations, the rights of the proponent and the public interest. Council must consider any submissions made before it decides whether to proceed with or abandon a proposal.

Where relevant, a Political Donation and Gift Disclosure Statement must accompany any submission lodged with Council. Under Section 147(5) of the Environmental Planning and Assessment Act 1979 any person who makes a submission to Council is required to disclose any political donation or gift.



# REFERENDUM FOR THE CONSTITUTIONAL RECOGNITION OF LOCAL GOVERNMENT

The Uralla Shire Council Supports a YES Vote for Financial Recognition of Local Government in the Australian Constitution.

The Uralla Shire Council has for many years campaigned for the recognition of local government in the Australian Constitution. The Federal Government on 29 May 2013 passed the bill (133 to 2) to enable a referendum to change Section 96 of the Constitution to enable payments to local Government bodies (see over for the official announcement).

The Uralla Shire Council is contributing \$9,339.27 towards the \$10 million YES campaign being run by the Australian Local Government Association. This campaign will commence in Mid-August 2013. The referendum will be held in conjunction with the Federal Election.

While the Uralla Shire Council would prefer a referendum to be held outside the election campaign, it fully supports the YES vote and asks its residents to vote YES.

# Who Contributes to the Running of the Uralla Shire Council?

While Local Government is a creature of the State, being formed under a State Act of Parliament, The Local Government Act 1993; the majority of the funding of the Uralla Shire Council is by the local residents in rates, fees and charges.

Surprisingly, the next largest funder of Uralla is the Federal Government and the State Government; that has the greatest control over our existence, roles and responsibility; makes the smallest contribution.

For those who think that a Yes vote for Constitutional recognition will increase the Federal Government's influence over local Government, the Federal Government is the largest supplier of governmental funding and the majority of the grants from the Federal

Government are un-tied—that is Council can determine where the funds are spent. Of the \$3,288,339 received in 2011/2012 from the State Government only \$106,180 was un-tied and that was for rebates of 55% of the pensioner rate concession granted on the State's behalf.

#### The Yes/No Case for Financial Recognition

In due course, the Electoral Commission will publish the official Yes/No case for the referendum, as prepared by Members of the Federal Parliament who support and oppose the proposal. Both sides will receive Federal Government funding for their campaign. The Federal Government has indicated that it will provide \$10 million for the Official Yes campaign and \$500,000 for the No campaign. On 23 May, the Constitutional Reform Unit (CRU) in the University of Sydney Law School, released an Alternative Yes/No case. A summary of the cases for and against, as identified by the CRU, is included in the table (right). ⇒

#### What Do We (Uralla Shire Council Residents) Have to Lose?

The longest term grant received from the Federal Government is the Financial Assistance Grant, which commenced in the late 1970s. Currently this is \$2,230,823. This grant is paid to local government through the State Governments and is not at risk.

The next longest term grant is the Roads to Recovery (R2R) made directly to local government by the Federal Government. The Uralla Shire Council's share is \$430,515 per annum. This payment, being direct, is at risk.

The most recent funding is payments through the Regional Australia Development Fund. Until this coming year the Uralla Shire Council had not received any funds through this program. For 2013/2014 and 2014/2015 Council will received \$1,020,630 for work on the Emu Crossing and Thunderbolts Way. This payment, being direct, is at risk.

# Section 96 of the Australian Constitution

Section 96 of the Australian Constitution (PDF 170KB)

The Australian Government announced that a referendum will be held to vote on a proposal to change section 96 of the Australian Constitution to recognise local government. The proposed change would allow the Commonwealth Parliament to grant financial assistance to local government.

#### What is the proposed change?

The proposed change is to amend section 96 of the Australian Constitution to make specific provision in relation to the granting of financial assistance to local government bodies.

Section 96 says that the Commonwealth can provide funding to the states and, if the Australian people agree to the proposed change in the referendum, it will also say that the Commonwealth can provide funding directly to local government.

The 17 new words that are proposed are as follows (in bold):

96. Financial assistance to States and local government bodies

During a period of ten years after the establishment of the Commonwealth and thereafter until the Parliament otherwise provides, the Parliament may grant financial assistance to any State, or to any local government body formed by a law of a State, on such terms and conditions as the Parliament thinks fit.

The amendment would not alter the current federal structure established by the Constitution.

Local government would continue to be the responsibility of state and territory governments. State and territory governments would continue to determine how local government bodies raise rates and make laws.

#### What now?

The change to the Constitution will only be made if a majority of people across the whole nation and a majority of people in a least four of Australia's six states approve the change. Participating in the referendum is compulsory for everyone on the Australian electoral roll.

It is therefore important that every Australian who is enrolled to vote is informed about the reasons for and against the proposed changed.
