Uralla Water Restrictions Lifted

Water restrictions have been lifted for Uralla. This decision resulted from the combination of rainfall in the Kentucky Creek Dam catchment and progress made to the ongoing repairs and upgrades to the water treatment plant filters.

We remain committed to improving water security for the Shire, including increasing the water efficiency of Council facilities, working with the community to reduce water consumption, and reviewing alternative water supply options.
