NOTICES

Landfill fees and Charges

Fees and charges are now strictly applied at Council landfill and waste transfer stations. The current structure of fees and charges has been in place for many years, and the set fees and charges are the same as they have been since 1 July 2013. Council require staff to charge the scheduled fees and charges, with no leniency granted to users of the facilities. A copy of the waste fees and charges is displayed at each waste facility, on the Council website or can be obtained from the Council office.

The general rule is that there is NO CHARGE for domestic (household) waste that has been sorted of recyclables. If waste contains recyclables and there has been no attempt by the resident to sort recyclables from their waste, then a waste fee is charged.

There is NO CHARGE for green waste, metal waste, car batteries, electronic waste, or items suitable for sale in the Council Op-Shop.

Items such as builders waste (even from DYI home renovations), hazardous waste, commercial waste, tyres, and mattresses and couches will attract a waste disposal charge.

Only residents of Uralla Shire are permitted to use the Uralla, Bundarra and Kingstown waste facilities. Residents may be asked from time to time to show proof of residency to Council staff, such as a drivers license or copy of commercial quote.

Builders Waste – it is the responsibility of the resident or business owner to prove that the material comes from Uralla Shire and does not contain ACM (asbestos containing material). If Council staff are unsure if the material contains ACM, they are required under Council Policy to treat the material as asbestos and charge an asbestos disposal fee.

Council Cleanup Day

Council is conducting an annual Council Cleanup on 10 and 11 November 2014. This cleanup will coincide with other events taking place for National Recycling Month. There is no Council cleanup in May 2014.

Graziers Help Out

Council would like to thank graziers who have been minding stock on Thunderbolts Way in the Yarrowyck district for collecting rubbish along the road and adjacent areas while they have been out with their stock. Your action has been noticed and appreciated by other road users.

Bundarra Water Restrictions

The 2 hours per day for hand held hoses has been amended to allow watering between 4 pm and 6 pm. This adjustment is due to the end of daylight saving. Bundarra's average usage is currently 90 kilolitres/ day. Council would request that residents continue to conserve water.

Ranger Services

Dogs and Cats

Uralla Shire council now provide a Ranger Service to the community. The Ranger covers mainly animal control issues at present, assisting the public with resolving and negotiating matters with neighbours' dogs barking, escaping and roaming. Also assisting people that have cat problems, these being cats that cause nuisances such as severe damage to others property and persistent noise that interferes with the peace, comfort or convenience of any other person in any other nearby premises. Microchipping and registration of dogs and cats is vital for all companion animal owners to have done as it assists them in serving the public with having the above issues resolved by Local Government Rangers, and have lost animals returned to their owner if they escape from their residential property.

DOG ATTACKS

Being involved as a victim to a dog attack can be quite traumatic and same goes for being a dog owner of a dog that attacks a person or animal though on most occasions it can be hard to accept. So therefore council always investigates these incidents thoroughly and with complete impartialness. There is quite an extensive process to go through let alone costs and emotions to deal with when being the dog owner. So council will always explain the options but it is known that once a dog bites a person or animal they are highly likely to do it again and if so next time could be a lot worse which is what we aim to avoid. Many don't understand that an attack is not just a dog biting someone. If a dog rushes at, harasses or chases a person or animal this is still considered a dog attack. In these instances there is discretion applied to decide what order or penalty is put on the owner responsible, on a case by case basis.
