OFFICIAL OPENING OF THE URALLA SWIMMING POOL

The community is invited to celebrate the Official Opening of the Uralla Swimming Pool by the Honourable Adam Marshall MP and Mayor Michael Pearce on Saturday, 16 November from 12pm to 2pm. The pool will offer free entry for the day, a free sausage sizzle, cold drinks and lolly bags.

The pool has a fresh look for the summer season following upgrades made possible by the grant funding secured through the Stronger Country Communities Programme Round 2. New features at the pool include picnic shelters, shade sails, double BBQ, billboard for public art to be provided by students from Uralla Central, and a new water bubbler.

Upgrades also included fibre-glassing and painting of the main pool's floor and walls, removal of the starting blocks, re-grouting of the tiled surfaces in the pool, rendering of the buildings, painting of internal walls in the amenities, and new shower hardware.

Council is also working with local schools to commission a large mural on the main building to face Wood Street which will be unveiled in the coming months.

Please join us on Saturday, 16th November to celebrate the upgrades to the Uralla Pool. Bring your families and friends, and don't forget your swimmers!

LEVEL 3 WATER RESTRICTIONS

Bundarra and Uralla are at Level 3 water restrictions. The implications of Level 3 water restrictions are:

- General watering of lawns and gardens using a hand held hose with a trigger nozzle is permitted for a maximum of one hour between the hours of 5pm and 9am.
- The use of sprinklers and fixed hoses, and watering new turf, is prohibited.
- Vehicle washing is restricted to cleaning windows.
- Cartage of town water for the purposes of watering stock is prohibited.

YOUR QUESTIONS ANSWERED FROM THE URALLA SUSTAINABILITY EXPO

On 3 August 2019, Council participated in the ZNET Sustainability Expo and hosted a display to showcase the recent initiatives in energy efficiency, solar energy, council's bush regeneration program and Uralla's urban water supply.

Along with face-to-face discussion, Council sought written feedback from the public. Council staff have reviewed the questions received and can now provide the following answers:

1. Can council focus on providing the community with water savings/strategies and goals, including a roadside display with dam and water restriction levels?

Yes. Council has access to materials through the New England Joint Organisation to provide strategies to conserve water use. The sustainability of our water supply depends on the sale of water to provide the income to cover the costs.

Water saving advice is available on Council's website together with storage levels and restriction details. Should Level 4 restrictions be implemented, roadside signage will be installed.

2. Can council provide recycling bins in the main street?

No. Too much contamination with general waste occurs. The contamination means waste from public recycling bins must be disposed of in landfill. When possible, it is more effective for people to take recyclables home and use their home recycling bin.

Council appreciates the recycling efforts by our community and encourages residents to check which materials can be recycled via the Council website.

3. Can Council encourage residents to invest in wind turbines to generate renewable energy by easing planning restrictions including the DA process?

Provisions around development that do not require planning approval are regulated by state planning policies, and Council cannot provide any relaxations in relation to the statutory requirements.

Development Applications are assessed on merit, meaning benefits of a proposed development are weighed against the environmental and physical constraints of the site.

4. Can Council control the distribution of Coolatai and African lovegrass within road reserves and on Travelling Stock Routes?

Travelling Stock Routes are under the care and control of Local Land Services. Council helps control roadside weeds by cleaning and removing seeds from maintenance and construction equipment when moving from site to site.

Council also makes an annual contribution to the New England Weeds Authority to control weeds along roads and on public lands throughout the Uralla Shire.

KEY COUNCIL ACTIONS - OCTOBER 2019

Councillor Strategic Planning Workshop

Councillors reviewed the decision making process and business goals for the Visitor Information Centre Improvement project. Councillors and staff will meet with key stakeholders to discuss recommendations from the meeting and how the VIC can improve its promotion of Uralla.

Extraordinary Meeting of Council

- Council appointed a selection committee of Mayor Pearce, Deputy Mayor Crouch, and Councillors Toomey and Strutt for the recruitment of council's permanent General Manager.
- The first interviews during the selection period were held on 21st October.
- The final interviews will be held on 12th November 2019.

October Ordinary Meeting of Council

- Council resolved to remove the current design for the tower in the Visitor Information Centre Upgrade and to consider alternatives as part of the project review which are consistent with the Uralla Shire Council Development Control Plan.
- Council adopted the Financial Statements for the year ended 30 June 2019, incorporating the General Purpose Financial Statements, Special Purpose Financial Statements and Special Schedules. The Financial Statements and Auditor's Report have been placed on exhibition with the date for submissions from the public closing on 3 December 2019.
- Council received the First Quarter Progress Report on the Combined Delivery Program 2017-21 and 2019-20 Operational Plan.
- Council determined to make a submission to the Minister for Local Government on Gifts and Benefits as part of the Model Code of Conduct Consultation, that:
 - \$50 is an appropriate cap for gifts; and
 - That councillors and staff should be treated equally under the Code.
- Noted the tabling of annual Interests Disclosure Returns by councillors and designated persons.
- Resolved the Notice of Motion be received as a submission to the Draft Amendment No 5 of the Development Control Plan for review and report back to Council.
- Provided hire of grandstands to the Australian Medieval Combat Federation at no cost.
