The Draft Local Strategic Planning Statement (LSPS) sets out the 20-year vision for Uralla Shire by planning for the community's economic, social and environmental land use needs, demonstrating how change will be managed, and identifying local priorities for updating the Local Environmental Plan (LEP).

There were a range of funding announcements in August including \$1.5million for groundwater exploration and any subsequent delivey of works in Uralla from the NSW Government.

## **New Multipurpose Courts for Bundarra**

Following Council's purchased of the land in 2018 Bundarra's tennis courts are set to be brought back to life in the form of a new multipurpose sports court, with Northern Tablelands MP Adam Marshall today announcing a \$300,000 grant for the project through the State Government's Drought Support program.

There will be a chance for the community to have their say on the project while the designs are finalised with work expected to start between November and January.



## Let's Talk About Water

Council has partnered with ZNET Plus to allocate staffing and promotional resources to assist in the delivery of the local community group's Let's Talk About Water project.

Building on the success of the Uralla ZNET blueprint project, ZNET Plus has received \$30,000 State government grant funding



for the project. The project is in partnership with the University of New South Wales (UNSW) and Global Water Institute.

Concurrently Council is finalising its Integrated Water Cycle Management Planning involving investigations and identification of future works in conjunction with the Department of Planning, Industry and Environment – Water to help secure the future for Uralla's water supply.

The goal is to provide an opportunity to deliver a strong community voice around the issues of water security in our Shire.

Council voted unanimously to support the initiative with ZNET Uralla at the August Ordinary Meeting of Council.
